Chippi General Terms of Use

The Terms of Use ("Terms") govern your use of the mobile applications provided by Chippi (or referred to as "us") (collectively the "Mobile App"). Please read these Terms carefully. By accessing and using the Mobile App, you agree that you have read, understood and accepted the Terms including any additional terms and conditions and any policies referenced herein, available on the Mobile App. Chippi may modify this Agreement from time to time, with or without notice, and your continued use of any of the Services or continued maintenance of an account with Chippi shall constitute and be deemed to be your acceptance of such modification and your consent to abide by any terms thereof.

1. Service License

Subject to this Agreement, Chippi hereby grants you a revocable, non-exclusive, non-transferable license (without the right to sublicense) to access and use the Chippi Mobile App. You agree that you obtain no rights other than the rights and licenses expressly granted under this Agreement. Chippi reserves the right to change, upgrade or discontinue any or all of the Services or the Chippi Mobile App or any feature of the Services or the Chippi Mobile App, at any time, with or without notice. All rights not expressly granted under this Agreement are reserved by Chippi and its licensors.

2. Chippi Account

The Services require the user to maintain an account with Chippi. A user may create an account free of charge by providing the relevant details requested for. Use of the account and the Services are offered at the sole discretion of Chippi and subject to your compliance with this Agreement.

An individual shall not create or have control and/or custody over multiple Chippi accounts. In particular each mobile number may only be linked to one Chippi account.

A failure to abide by any terms and conditions, any fraud or abuse relating to the accrual or receipt of Voucher rewards, and/or any misrepresentation of any information furnished to Chippi or its affiliates may result in your Chippi account being flagged for suspicious activity and suspended or terminated and any Voucher accumulated being forfeited.

You are responsible for regularly checking your account to ensure Voucher has been properly credited. You must notify Chippi of any omissions, incorrect entries or discrepancies concerning any transaction within 30 days after that transaction. Chippi reserves the right not to correct any omissions, incorrect entries or discrepancies brought to its attention after the 30-day period.

3. Collecting Voucher

Chippi offers the opportunity to collect Voucher at our various merchant partners through our Chippi Mobile App. Creating and maintaining an account with Chippi is required before a user can start collecting Voucher. Crediting of Voucher is also subject to the various terms, conditions and requirements, express or implied, associated with the crediting of Voucher in general or terms, conditions and requirements associated with the individual promotions that would be applicable.

In addition, certain purchases may be excluded from Voucher. In general, Voucher is collected on the net purchase amount excluding shipping and handling. However, Voucher amounts and exclusions vary from merchant partner to merchant partner and individual promotions may contain specific exclusions. Please review these terms carefully. These exclusions are subject to change without notice, and Chippi hereby disclaims any and all liability in connection with any incorrect information or failure to include information on the list of exclusions. Some examples of typical exclusions include (but are not limited to):

- (a) Voucher not being eligible when purchasing promotional items or using other discount codes, coupons or other promotions;
- (b) Voucher only being eligible when the transaction is completed using specified payment methods; and
- (c) Voucher not being eligible when a legitimate or valid transaction is not deemed by Chippi to have been made (e.g. where a user makes a fraudulent or dishonest transaction to collect and/or redeem Voucher); and
- (d) Different tiers of eligible Voucher for different users (e.g. different tiers of Voucher for new users and existing users)

4. Merchant Partner Policies

Any products or services purchased from any merchant partner, whether through Chippi or otherwise, are governed by and subject to the applicable merchant partner's policies and terms and conditions, including but not limited to the applicable return, cancellation, and exchange policies. You agree that we are not agents of any merchant partner and that the merchant partner operates independently and is not under our control. Accordingly, your participation in offers or promotions of, or correspondence with, any merchant partner is solely between you and that merchant partner. We do not assume any liability, obligation or responsibility for any part of such correspondence, offer or promotion, including, without limitation, the withdrawal or modification of any such offer or promotion. Chippi is not responsible for changes to, or discontinuance of any merchant partner from any of Chippi's Mobile App or the termination of any promotion offered by any merchant partner on any of Chippi's Mobile App, or for any effect on accrual of Voucher caused by such changes, discontinuance, or withdrawal. Chippi assumes no responsibility and shall not be liable for any content, product and/or services on the merchant's Mobile App (including but not limited to the quality, merchantability or fitness of such

products or services or that such content, product and/or services do not breach any laws or regulations).

5. Redeeming Voucher

You may redeem your Voucher at any time subject to the terms and conditions of this Agreement or the specific conditions that relate to the individual entries in your account. In order to redeem your Voucher, you must maintain an active account and provide the minimum relevant information required to process the redemption (e.g. your phone number).

6. Nature of Voucher

For the avoidance of doubt, you do not gain any proprietary right over any monies or assets held by Chippi when you collect Voucher in your account. The Voucher accrued in your account does not constitute monies held on trust by Chippi for your benefit. Your rights and entitlements are solely limited to such personal or contractual rights of repayment as may arise out of this Agreement.

7. Billing

Chippi offers a free and paid Service. You can learn more about Chippi subscription offerings here. If you are on a Chippi Pro Plan, the Main Business's Owner will be billed for and is responsible for payment of subscription fees.

- (a) Subscriptions and Renewals. If you are subscribing to Chippi Pro, you are signing up for an annual subscription. Your subscription will automatically renew on an annual basis as of the latest pricing. We'll notify you before auto-renewal of your subscription. You can cancel your subscription at any time. If you cancel your subscription, you will not receive a refund or credit for any amounts that have already been billed.
- b. Taxes. Your subscription fees are exclusive of all taxes unless otherwise specified in an agreement with Chippi, within the Service or on an applicable invoice.
- c. Cancellation. You can stop using the Service and/or cancel your subscription at any time via your account settings. If you cancel your subscription you will not be entitled to a refund of any fees already paid and any outstanding fees will become immediately due and payable.
- d. Free Plan. Chippi offers you a free plan to allow you to try our Service. Canva reserves the right to set and update the scope, limitation and the duration for free plan without notifying the existing subscribing merchants.
- e. Changes to Pricing. Chippi reserves the right to change its prices at any time. If you are on a subscription plan, changes to pricing will not apply until your next renewal or thirty (30) days after notice, whichever is later.

f. Billing Communications. You agree that Chippi may contact you at any time by email, push notifications, or other method with information relevant to your subscription, billing, and use of the Service.

8. Refund Policy

If you are subscribing to Chippi Pro Plan, you can stop using the Service and/or cancel your subscription at any time via your account settings. If you cancel your subscription within 14 calendar days following the start of your subscription to the Pro Plan, you are entitled to a full refund.

If you are entitled to receive a refund, please contact us via hello@chippi.app for further information on the refund procedure. Any refund of subscription fees will be made with the same payment method you used for payment of the subscription fees. You agree to comply with this refund policy and any of our further communications with you on refund, if any.

Notwithstanding the foregoing, if you subscribe to the Chippi Pro Plan through Apple Pay or Google Pay, your cancellation and refund is further subject to the terms and conditions of Apple App Store or Google Play.

If you cancel your subscription 14 calendar days following the start of your subscription to the Chippi Pro Plan, you will not be entitled to a refund of any fees already paid and any outstanding fees will become immediately due and payable.

9. Termination of Account

The Voucher accumulated in your Chippi account shall forfeit if your terminate your Chippi account. Chippi reserves the right to suspend or terminate your account where it is necessary or reasonable to do so in order to comply with or satisfy any law, regulation or court order.

10. Personal Data Protection

Personal Data collected is subject to our Privacy Policy, which is hereby incorporated by reference, and a copy of which is located on Chippi Mobile App.

11. Fraud

Chippi may suspend or terminate your account if it has reason to believe you are involved in any fraudulent or dishonest activities. Any failure to comply with this Agreement, any fraud, dishonesty or abuse relating to the use of the services or your account, or any misrepresentation of any information furnished to Chippi or its affiliates by you or anyone acting on your behalf may result in the termination of your account and forfeiture of your accrued Voucher rewards.

12. Communications

By becoming a Chippi user, you agree to receive communications that are account and user-related (e.g. that we've added Voucher to your account, you have an expiring voucher etc) as well as periodic shopping-related e-mails that highlight vouchers available to Chippi users. We may communicate with you regarding your account by electronic communications you provide during the registration process. Your consent to receive electronic communications include any notices or other information that we may be required by law to provide you in writing or otherwise. We may also send you to push notifications if you install the mobile application.
